Reader's Confidentiality Agreement

This Confidentiality Agreement (this "Agreement") is made between **Mythical Legends Publishing** (James C Jones II), of P.O. Box 1667, Inglewood Ca 90308, and his successors and assigns, hereinafter referred to as the PUBLISHER, and **the Reader**, named below in the area titled **SECTION INFORMATION**, hereinafter referred to as the Reader.

The parties agree as follows:

I. PAYMENT FOR SERVICES. The Reader shall be paid based on the word count and pay scale rate for total word count in the area titled **SECTION INFORMATION**.

II. CONFIDENTIAL INFORMATION. The term "Confidential Information" refers to any story/article, hereafter referred to as the WORK, assigned to the Reader to read and evaluate the merit of the Work to be published.

III. PROTECTION OF CONFIDENTIAL INFORMATION. The Reader understands and acknowledges that the Confidential Information has been developed or obtained by the Creator of the Work by the investment of significant time, effort and expense, and that the Confidential Information is a valuable, special and unique asset of the Creator which provides Publisher with a significant competitive advantage and needs to be protected from improper disclosure. In consideration for the disclosure of the Confidential Information, Reader agrees to hold in confidence and to not disclose the Confidential Information to any person or entity without the prior written consent of Publisher. In addition, Reader agrees that:

i. No Copying/Modifying. Reader will not copy or modify any Confidential Information without the prior written consent of Publisher.

ii. Application to Employees. Further, Reader shall not disclose any Confidential Information to any person not associated with the Creator or the Publisher without the prior written consent of Publisher.

iii. Unauthorized Disclosure of Information. If it appears that Reader has disclosed (or has threatened to disclose) Confidential Information in violation of this Agreement, Publisher shall be entitled to an injunction to restrain Reader from disclosing, in whole or in part, the Confidential Information. Publisher and Creator shall not be prohibited by this provision from pursuing other remedies, including a claim for losses and damages.

IV. RETURN OF CONFIDENTIAL INFORMATION. Upon the written request of Publisher, Reader shall return to Publisher all physical written materials, if received, containing the Confidential Information.

V. LIMITED LICENSE TO USE. Reader shall not acquire any intellectual property rights under this Agreement.

VI. GENERAL PROVISIONS. This Agreement sets forth the entire understanding of the parties regarding confidentiality. Any amendments must be in writing and signed by both parties. This Agreement shall be construed under the laws of the State of California. This Agreement shall not be assignable by either party, and neither party may delegate its duties under this Agreement, without the prior written consent of the other party. The confidentiality provisions of this Agreement shall remain in full force and effect after the effective date of this Agreement.
